MANDATORY CODE OF CONDUCT

All players, coaches and parents must sign the GSBL Code of Conduct. All participants in the GSBL will be held responsible for their actions during league play. The Code of Conduct must be submitted via fax to the league headquarters at **(763) 781-1922** or scanned and sent electronically to CJ@myas.org by April 18 (9u-12u), April 25 (13u-14u) or May 8 (15u). ***A \$5.00/day late fee will be assessed to any team that does not submit their completed/signed Code of Conduct by the listed deadline.***

Coaches must read the following information to their coaches, players and their parents prior to the start of the season.

- 1) I will not berate the umpires or “trash talk” to my opponent!
- 2) I will not use profanity!
- 3) I will encourage good sportsmanship by demonstrating positive support for all players, coaches, contest administrators and umpires at every game.
- 4) I will place the emotional and physical well being of my teammates and opponents ahead of my personal desire to win.
- 5) I will treat other players, coaches, fans and umpires with respect regardless of race, gender, creed or ability.
- 6) I will demand a sports environment that is free from drugs, tobacco and alcohol and will refrain from their use at all MYAS/GSBL league and playoff games.
- 7) I will do my best to remember that youth sports, is supposed to be FUN and that winning and losing are part of everyone’s experience.
- 8) I will express my concerns through the proper channels in a dignified manner.
- 9) I will respect the volunteers who are assisting with the conduct of these events.
- 10) I will respect and adhere to the rules governing eligibility and competition.

PENALTY

Any violation of the GSBL Code of Conduct may result in temporary or permanent banishment from any MYAS sponsored events.
